# Hurricane Helene Resource List

On Sunday, September 30, 2024, U.S. Senator Tim Kaine wrote a <u>letter</u> to President Biden expressing support for an Expedited Major Disaster Declaration for the Commonwealth of Virginia following significant damage caused by remnants of Hurricane Helene. His advocacy was successful and President Biden <u>approved</u> an Expedited Major Disaster Declaration for Virginia, which will surge federal resources to impacted areas and help Virginia more quickly respond to and recover from Hurricane Helene's impacts. This builds upon President Biden's earlier <u>approval</u> of a federal emergency declaration for Virginia, which Kaine also <u>advocated for</u>.

Senator Kaine is continuing to work with federal and state agencies to secure resources and assistance to affected Virginians, and encourages Virginians to consider the following resources:

# INDIVIDUAL ASSISTANCE

Under the Expedited Major Disaster Declaration, Virginians in Giles, Grayson, Montgomery, Pulaski, Smyth, Tazewell, Washington, and Wythe, and the City of Galax may apply for Individual Assistance. This list may be expanded to additional localities over time. Individual Assistance provides financial support and direct services for eligible individuals and households impacted by a disaster. For in-person support in getting connected with resources or completing assistance applications, residents in Giles, Grayson, Montgomery, Pulaski, Smyth, Tazewell, Washington, and Wythe counties and the City of Galax can visit the <u>Disaster Recovery Center</u> (DRC) in Damascus Monday through Saturday, 8 AM to 6 PM: Damascus Shopping Mall 736 North Beaver Dam Avenue Damascus, VA 24236

Additional DRCs are expected to open in the coming weeks in other Southwest Virginia communities.

### STATE PRICE GOUGING PROTECTIONS IN EFFECT

Virginia's Anti-Price Gouging Act prohibits a supplier from charging "unconscionable prices" for "necessary goods and services" following a declared state of emergency.

Items and services covered by these protections include, but are not limited to, water, ice, food, generators, batteries, home repair materials and services, and tree removal services.

### SMALL BUSINESS ADMINISTRATION (SBA) LOANS

Low-interest disaster loans from the U.S. Small Business Administration (SBA) are available to businesses and residents in Giles, Grayson, Montgomery, Pulaski, Smyth, Tazewell, Washington, and Wythe counties and the City of Galax.

There are three types of loans available to businesses and residents in Giles, Grayson, Montgomery, Pulaski, Smyth, Tazewell, Washington, and Wythe counties and the City of Galax:

- SBA Business Physical Disaster Loans: Loans of up to \$2 million to repair or replace disaster damaged property owned by a business, including real estate, inventories, supplies, machinery, equipment, and other business assets. Businesses of any size are eligible. Private, non-profit organizations, such as charities, churches, private universities, etc., are also eligible. <u>The deadline to apply is December 2, 2024.</u> More information is available here: <u>https://www.sba.gov/funding-programs/disaster-assistance/physical-damage-loans</u>.
- SBA Home and Personal Property Loans: Loans available to homeowners and renters to repair or replace disaster-damaged or destroyed real estate. Eligible homeowners may apply for loans up to \$500,000 to repair or replace their primary residence, and eligible renters and homeowners may apply for loans up to \$100,000 to repair or replace personal property, such as clothing, furniture, cars, and appliances damaged or destroyed in a disaster. - SBA Economic Injury Disaster Loans (EIDLs): Working capital loans to help small businesses, small agricultural cooperatives, small businesses engaged in aquaculture, and most private, non-profit organizations of all sizes meet their ordinary and necessary financial obligations that cannot be met as a direct result of the disaster. These loans are intended to assist through the disaster recovery period. The deadline to apply is July 1, 2025. Small businesses and most private nonprofit organizations in the following adjacent counties are also eligible to apply for EIDLs: Bland, Buchanan, Carroll, Craig, Montgomery, Pulaski, Russell, and Scott counties and the City of Bristol.
