3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Fully Funding our Na-
- 5 tional Security Priorities Act".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

1 (1) A report issued by the Department of State 2 in 2023 identified a \$41,300,000,000 gap between 3 the resources made available to the Department of 4 State and the United States Agency for Inter-5 national Development and the resources required to 6 effectively counter the People's Republic of China in 7 the Indo-Pacific region. 8 (2) While the Department of State and the 9 United States Agency for International Development 10 remain less than fully funded, the PRC has provided 11 some \$1,340,000,000,000 in grants and loans over 12 the past 22 years. In October 2023, the PRC and 13 President Xi additional announced an 14 \$100,000,000 for China's development banks.

(3) As competitors like the PRC and Russia expand their global diplomatic footprints, the Department of State today has, on average, a 13 percent
staffing gap.

19 SEC. 3. SENSE OF CONGRESS.

20 It is the sense of Congress that—

21 (1) the United States is a beacon of democracy22 and freedom in an increasingly fraught world;

(2) the Department of State, as a critical national security agency, remains chronically understaffed and underfunded at a time when geopolitical
